One month to the 9th European Economic Congress

Organisers expect record turnout

Katowice, 11 April 2017 – **The 9th edition of the European Economic Congress is scheduled to take place on 10-12 May 2017 in Katowice. Nearly 100 sessions will bring together several hundred participants, including members of the Polish and the European Parliament, government officials from Poland, Europe and across the world, as well as business people and CEOs of the largest companies. The Congress will also be accompanied by the second edition of the European Start-up Days, a special event designed to bring together start-ups and corporations.**

The European Economic Congress (EEC) in Katowice is a three-day series of debates on a varied range of topics that address the current economic situation in Poland, Europe and the world. The event stands out in particular for its representative selection of panellists. The ninth edition is expected to attract a record turnout.

“The European Economic Congress is an excellent platform to exchange knowledge and ideas, as well as to hold debates to identify key solutions for the future of our economy. It’s also an event with an already well-established presence, renown, and prestige. Last year, it attracted eight thousand visitors. The great interest shown in the 9th European Economic Congress thus far allows us to estimate that the turnout will be even greater this year”, comments **Wojciech Kuśpik**, initiator of the EEC, CEO of PTWP SA.

Every year, the European Economic Congress brings together EU Commissioners, members of the Polish and the European Parliament, ministers and deputy ministers from Poland, Europe and around the world, CEOs of the largest companies, many business people from Europe, Africa and Asia, and also representatives from financial institutions and local governments.

The leading themes of the 9th EEC will include new ideas for Europe – political changes within the EU; the post-Brexit economy and the likelihood of other exits; the crisis in the perception of liberal capitalism; the hierarchy of economic values in the light of new generations of employees; the fourth industrial revolution – how to develop industry with the help of digitisation and advanced technologies; investment in unstable times – risks, barriers, courage and profits.

The agenda will also feature some regular topics, namely sessions devoted to various areas of public and economic life, such as finance, innovation, man and technology, energy and resources, mining and steel industry, management, self-government and regional policy, infrastructure, the health market, transportation and logistics, real property and construction, and also global economic co-operation.

The 9th European Economic Congress will once again be accompanied by the [European Start-up Days](#) – a space of open dialogue for start-ups, investors and business support organisations. The participants will have a chance to present their start-ups before the audience of the EEC by taking part in the Start-up Challenge. Authors of the top 100 most interesting business ideas will present their projects at free stands prepared by the organiser in a dedicated Scale-up Alley. The top eighteen will also be invited to appear on the stages of the European Economic Congress at the International Congress Centre in Katowice, as well as in front of the audience for the European Start-up Days at the Spodek Sports and Entertainment Arena.

The organisers of the European Economic Congress in Katowice have also decided to continue the **EEC – Leaders of Tomorrow** project, which aims at shaping and promoting active citizenship, as well as increasing the involvement of young people in public life. The project invites students to open lectures, allowing them to participate in the congress as a speaker or listener, and helping organise the event.

A special accompanying gala will also present awards to the best practices and top investment success stories in the framework of the sixth edition of the **Top Communal Investments** contest. This year the board, composed of experienced self-government delegates, economists, managers, experts and officials, will select winners from among projects carried out under the public-private partnership formula (PPP).

All discussions, meetings, presentations and information-sharing sessions will be hosted at the International Congress Centre in Katowice and the adjacent Spodek Sports and Entertainment Arena.
